### Our new DCS Education Welfare Officer (EWO) – Attendance



Defence Children's Services (DCS) offer several services to MOD families one of which is Education Welfare. My name is **Jane Kelly**, and I am Attenborough School's Education Welfare Officer (EWO). I also cover Rest of World Schools both MOD and our Host Nation providers.

As a non-teaching professional working within the education system, my role as an Education Welfare Officer is to safeguard and promote the well-being of students, ensuring they have access to a safe and supportive learning environment. I work closely with Headteachers, parents, and other professionals to identify and address any barriers to a student's education, such as attendance issues, relating to welfare

and engagement.

I commenced working for Defence Children's Services at the end of January 2023. I have a broad background of knowledge and experience in childcare, education, and training. Working with children, young people and families has always been an integral part of all my roles undertaken within my employment history. I have over 15 years' experience in Education Welfare management and most recently I have worked as an Education Welfare Officer for a Local Authority in England before moving over to the MOD.

I was born in England and raised in Australia. I returned to England on a working holiday in my early 20's where I met my husband of 30 years! We have two children aged 21 and 18 years old.

I can certainly relate to the journey family life takes you on and navigating this terrain can be incredibly rewarding but bumpy at times. #### <u>Update on DCS Attendance Directive 3.2.6</u> (Exceptional term time leave – hospital appointments – update for 2024-25 in red below)

Valid reasons for **authorised absence** are:

a. Illness and medical/dental appointments. (to comply with termly DCS Attendance Reviews, to gain authorised approval – please can parents now also provide confirmation of hospital appointments when completing authorised absence requests for criteria a)

b. Religious observance – where the day is exclusively set apart for religious observance by the religious body to which the pupil's parents belong. If necessary, the school will seek advice from the parents' religious body to confirm whether the day is set apart.

- c. Post Operational Leave.
- d. Family terminal illness, bereavement or significant event.

\*Family holidays are not justified reasons for authorised absence during term time and will be registered as unauthorised absence. Exception: when in year amendments to the school's published academic calendar are made.

\*POL and Exceptional Leave request forms can be collected from the Main Office. They are also available via DCS Attendance Directive 3.2.6 on our website (Annex B and C).

Please note that DCS Attendance Directive 3.2.6 will be reviewed in November – updated versions of the directive will be communicated to all parents and shared on our website. In addition, significant changes will be highlighted in future Attendance Matters termly updates.
